UK We pay particular attention to selecting high quality materials and using manufacturing techniques that allow us to create products that are both design lead and durable. The products benefit from a 15-YEAR warranty covering manufacturing defects from the date of purchase (in case of purchase in store) or the date of delivery (in case of purchase on the Internet), without additional cost for normal domestic use (no commercial or pro-punitive).

To file a claim under this warranty, you must present your proof of purchase in the form of a receipt, purchase invoice or any other proof admissible under UK consumer law 2015 chapter 2 / 5. Keep your proof of purchase in a safe place. For this warranty to apply, the product you purchased must be new. The warranty does not apply to second-hand products or exhibition models. As required by applicable law, any replacement product provided under this warranty will only be warranted until the original warranty period has expired.

This warranty covers defects and malfunctions of the product, provided that the product has been used in accordance with the use for which it was intended, that it has been installed, cleaned and maintained in accordance with the information contained in these general conditions as well as in the user manual, and in accordance with practice, providing that this does not go against clear guidelines given in the user manual.

This warranty does not cover defects and damage caused by normal wear and tear or damage that may result from improper use, installation or defective assembly, or negligence, accident, misuse or modification of the product. This guarantee does not cover additional costs (expedition, transport, installation or reinstallation costs, including labour, etc.), nor direct or indirect damage. This warranty is valid in the country where you purchased this product. Any warranty claim must be addressed to distributor where you purchased this product. This warranty is in addition to, but not affects, your rights under UK law.

If you have purchased this product in United Kingdom, in addition to this commercial guarantee, the seller remains required to respect the legal guarantee of conformity provided under the Consumer Rights Act (CRA 2015). The UK consumer code chapter 2 article 19 & 23 that concerns the hidden defects of the product sold under the conditions provided for in chapter 2 articles 2 & 5. The distributor from whom you purchased this product is liable for any lack of conformity or defect of the product, in accordance with these provisions.

By virtue of CRA 2015 chapter 2 / 5 of the UK consumer code, when the buyer asks the seller, during the duration of the commercial guarantee that was granted to him during acquisition or repair of movable property, a restoration covered by the guarantee, any period of immobilization of at least seven days is added to the duration of the guarantee that remains to run. This period shall run from the buyer's request for intervention or from the making available for repair of the goods in question, under CRA 2015 chapter 2 - 23 if such making available is prior to the application for intervention. Legal guarantee of conformity. CRA 2015 chapter 2 / 19 of the Consumer Code - The seller must deliver a good in conformity with the contract and responds to the defaults of conformity existing at the time of delivery. Legal guarantee on hidden defects (extract from the CRA 2015 chapter 2 / 18 - The seller is bound by the guarantee in the event of hidden defects of the object sold which make it unsuitable for the use for which it is intended, or which diminish this use so much that the buyer would not have acquired it, or would have given only a lower price, if he had known them. CRA 2015 Chapter 2 / 24, any claim resulting from hidden defects must be made by the buyer within two years from the discovery of the defect.

1. Manufacturer's Warranty: 15-year warranty (excluding hardware with a warranty of 2 years).

2. The warranty covers defects resulting from improper manufacture of the product or faults in the materials used.

3. The warranty is applicable if the products have been stored correctly. Store your product protected from weather in a dry and ventilated room, with an air humidity not exceeding 60 % (+ - 5) in an atmosphere (humidity and temperature) closest to that where the product will be used.

4. Installation must be carried out in accordance with the installation instructions and DTU 56.5. Follow the requirements of the installation instructions supplied with the product.
